The Board of Commissioners considered for adoption Resolution (RES2024003) Declaring Intent in Support of Authorizing NCDOT to consider abandonment of a portion of Pine Oak Road.

Mr. James Kelly, Traffic-Transportation Project Engineer, provided an overview of the request. He noted that the Town was requesting that NCDOT abandon a portion of Pine Oak Road (0.431 miles) from east of existing bridge to NC-16 to allow the adjacent development to construct a mini roundabout on the proposed town-maintained portion of Pine Oak Road.

**MOTION** was made by Commissioner Wesolek to adopt Resolution (RES2024003) Declaring Intent in Support of Authorizing NCDOT to consider abandonment of a portion of Pine Oak Road. **MOTION** carried unanimously (5:0).

#### **Board of Commissioners**

· Commissioner Daunt expressed his gratitude to the residents both attending in-

person and remotely and to Town Staff for their hard work in the preparations of these meetings. and all online for the participation. He noted that he participated in a 2x2 meeting process that staff organizes. He explained the process of the 2x2 meetings, which splits the board in two groups to avoid the limits of open meetings statutes. These statutes are intended to ensure that decision making on public matters is public by specifying a maximum number of officials who can meet privately to discuss government business. The rationale for the 2x2 meetings is that they allow the staff to take the temperature of the board on various matters before discussing them publicly. The idea is that it would save the staff from spending too much time on matters that would not survive public presentation before the board. Additionally, the 2x2 process also costs the staff time because they have to make the same presentation three times before 3 different pairing of board members. He added that a lot of public resources are being spent on avoiding public scrutiny. The 2x2 process also violates the spirit of the open meeting statutes and that consensus is developed behind closed doors. His opinion in this manufactured consent has the effect of suppressing citizen engagement in out local government and people feel left out of the decision making process. He also added, that the BOC will be discussing the 2x2 meetings at their Annual Retreat on Thursday and Friday and encouraged everyone to attend in person or remotely.

**WHEREAS**, David G. Barnes served multiple terms as a Commissioner and Mayor Pro Tempore from 1979 – 2007 as well as serving on many town committees;

WHEREAS, David G. Barnes was a great advocate for the Town and its citizens, carrying out his responsibilities as a public servant with a dedication to the Town of Waxhaw and its citizens as he sought continuously to make Waxhaw a better place to live and visit;

WHEREAS, David G. Barnes exemplified the true meaning of a "dedicated public servant." He was instrumental in several town projects including the pedestrian bridge reconstruction, the Harvey Clay Nesbit Park dedication, water and sewer system improvements throughout town, and several annexations and subdivision developments;

WHEREAS, David G. Barnes served as a teacher for 28-years at Waxhaw Elementary. He was a role model, mentor, cheerleader, helper to all his students, and he remains one of the most highly respected educators in the history of Waxhaw;

WHEREAS, On August 28, 2009, David G. Barnes was honored for his impact on the lives and history of Waxhaw with the dedication of the David G. Barnes Park; and

**WHEREAS**, David G. Barnes was devoted to his family, friends, and students and will be missed by all those whose lives he touched during his life.

WHEREAS, the distributed funds will be received as Revenue and the budget account updated;



# A Resolution Declaring Intent of the Board of Commissioners of the Town of Waxhaw in Support of Authorizing North Carolina Department of Transportation to Consider the Abandonment of a Section of Pine Oak Road

WHERAS, North Carolina General Statute 160A-299 authorizes the Town of Waxhaw Board of Commissioners to close streets and public alleys;

# NORTH CAROLINA STATE DEPARTMENT OF TRANSPORTATION REQUEST FOR ADDITION TO STATE MAINTAINED SECONDARY ROAD SYSTEM TOWN OF WAXHAW, NORTH CAROLINA

(Resolution RES2024003)

Road Descriptions: <u>Pine Oak Road SR-1304, 0.431 miles from intersection of S. Providence</u> Road to Waxhaw-Marvin Road, leaving NCDOT 0.829 miles.

WHEREAS, the attached petition has been filed with the Town Council of the Town of Waxhaw, Union County, requesting that the above-described road, the location of which has been indicated on the attached map, be added to the Secondary Road System; and,

WHEREAS, the Town of Waxhaw is of the opinion that the above described road should be added to the Secondary Road System, if the road meets minimum standards and criteria established by the Division of Highways of the Department of Transportation for the addition of roads to the System.
